SUMMARY

Open Educational Resources (OER) - learning, teaching and research materials in any format and medium that reside in the public domain – and Open Educational Practices (OEP) around the creation, use, and management of OER to improve quality and innovate education are cornerstones of modern day education and training. The **UNESCO-UNEVOC Global OER Grant Programme** provides **5 grants of up to 5,000 USD** to institutions that develop, adapt or curate these resources to promote practices in **Technical and Vocational Education and Training (TVET)**. Applications are invited through an **open call for proposals** as per the deadline below:

Launch of OER Grant Programme: **3 December 2019**

Deadline for proposals: **12 January 2020**

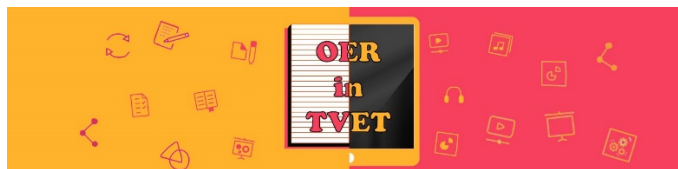
Grant recipient announcement date: **31 January 2020**

Project rollout and implementation: **between February and September 2020**

About the UNESCO-UNEVOC OER Grant programme

The [Recommendation Concerning Open Educational Resources](#) adopted by UNESCO Member States in November 2019 puts forward the following expectation:



"In building inclusive Knowledge Societies, Open Educational Resources (OER) can support quality education that is equitable, inclusive, open and participatory as well as enhance academic freedom and professional autonomy of teachers by widening the scope of materials available for teaching and learning."

It defines as one objective *"to develop a global pool of culturally diverse, locally relevant, gender-sensitive, accessible, educational materials in multiple languages and formats."*

With our Global OER Grant Programme we aim to promote OER and motivate the global TVET community to develop OER and related initiatives and practices. A [study commissioned by UNESCO-UNEVOC](#) in 2018 on the use of OER in TVET found that the OER concept was still widely unknown among TVET stakeholders. At the same time it was seen as highly promising for improving access to high-quality TVET. Our call for proposals is directed to institutions (e.g. TVET schools, training providers, teaching and learning centres, teacher training institutions, libraries, OER working groups, etc.).

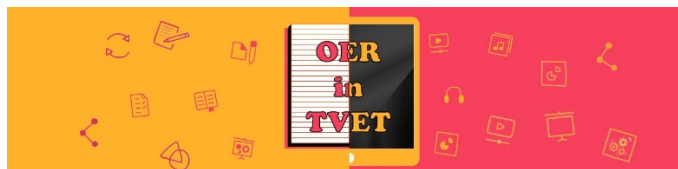
What type of projects are covered?

The OER/OEP must concern a subject area linked to [Technical and Vocational Education and Training](#). We explicitly welcome the development of resources not only for formal education streams, but also for informal settings. The grant may be used for, but is not limited to:

- Creation of new OER for TVET including textbooks, online courses, curricula, animations, multimedia resources etc.
- Adaptations, localizations and repurposing of existing OER on the basis of existing resources, for example adaptations and translations of existing OER, including textbooks, online courses, curricula, animations, multimedia resources etc.
- Creation or introduction of platforms for sharing of OER/OEP
- Turning existing (closed) resources into open resources

OER training can be part of the proposal, but ultimately there needs to be a **tangible output with an open license** that contributes to open educational practices in TVET.

Although this call for proposals is only issued in English, we do encourage the creation of resources and open practices in other languages. However, we need to be able to assess it, so a summary of the output needs to be made available in English or French (translation can be paid from the grant).



What type of projects / proposals will not be considered?

The focus of the Grant is on the development of OER and OEP allowing users to freely retain, copy, modify, remix, and/or redistribute open content. Proposals containing the following will **not** be considered:

- Projects that have the purchase of hardware or tools as a key component
- Projects that do not aim for an output that can be openly shared with the wider TVET community

Who can apply?

The Global OER Grant Programme is open for institutions only. Individuals with innovative ideas are welcome to partner with local institutions, as payments can only be made to institutions (including NGOs). Preferably, the implementation is carried out in cooperation or with support of a [UNEVOC Centre](#). A selection committee comprising of Robert Schuwer (Fontys University, Netherlands), Ben Janssen and other international partners will evaluate proposals meeting the following criteria:

- the final product has to be a tangible output that can be shared with the global OER community (an open resource or a guide on Open Educational Practices that can be followed as example by others) via UNESCO-UNEVOC
- the output has to be released with an [open licence](#), such as a [Public Domain](#) or [Creative Commons license](#), which conforms with the 5R requirement, i.e. allows others to freely retain, copy, modify, remix, and/or redistribute the content
- the expected contribution to a learning outcome should be described clearly
- the proposal clearly describes how the requested grant will be used and what expenses it will cover
- proposals need to indicate the in-kind contribution and any other resources necessary to complete the project, such as the assistance of students, instructors and trainers, instructional designers, multimedia developers, librarians, copy editors etc.

We encourage collaboration of multiple institutional partners. In this case, the applicant must designate a lead representative for the project and submit the proposal through the lead partner. Make sure that the respective roles of the project partners are clearly defined.

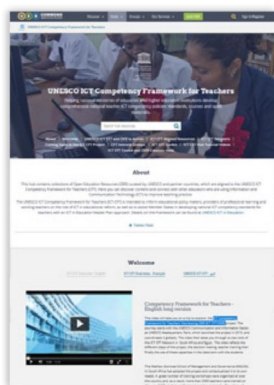

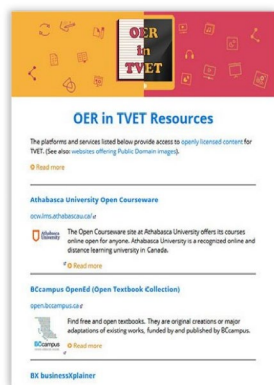

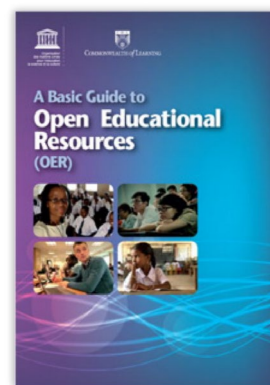
